#### Agenta Aduanal

Customs Broker, U.S. or Mexican

#### Arancel

Customs duties

#### **Border Zone**

An area 21-28 kilometers in Mexico Along the U.S. border; includes all of Baja California

#### Carta Cupo

Document used by Mexican bonded warehouse permitting goods to move inbond to their warehouse

#### Certicicate of Origin

A statement authenticating the country of origin of the product whether NAFTA or non-NAFTA countries

#### Comercializadoramm

A Mexican trading company used to import goods when consignee is not a registered importer

#### Commercial Invoice

Invoice showing product description, value and quantities of each product sold

#### **Custodial Bond**

Transportation company's bond used to move cargo to destination without paying duties

#### Cuota

Fee

#### Diario Official

Newspaper published daily reporting newly passed laws

#### DTA

Mexican customs port usage fee

#### **Duties**

Monies paid to a Government for importing goods from a foreign country

#### Factura

Commercial invoice

#### Fianza

Surety bond-needed by all foreign-owned trailers taken beyond Border zone

#### **Foreign Trade Zone**

Area in the U.S. designated as outside the customs territory

#### **Honorarios**

Mexican broker fees

#### I.E.-Customs Form #7512

Document used for immediate export within the same port

#### IT Customs Form #7512

Document used to move goods from port of entry to bonded facility

### IMMEX (Industria Manufacturere, Maquiladora Y de Servicios de Exportation)

A Mexican import - export program that allows qualified companies to import goods into Mexico on a temporary basis. (Formerly known as Maquiladora or Pitex program.)

Movement of cargo on Custodial Bond

#### In-pars/Pars

Inland pre-arrival review system pre-clearing shipments to and from Canada

#### IVA

Acronym for Mexican Federal tax - a value added tax Maquiladora

An assembly company in Mexico which imports parts and exports finished goods investors involved

#### **NAFTA**

North American Free Trade Agreement

#### Nom Certification

Certifies that imported products meet Mexican's standards

#### PA.M.A.

Mexican customs document detailing irregularities found upon inspection See Red light

#### **Packing List**

Itemized list of products being shipped

#### Pedimento

Mexican customs document detailing duties and taxes

#### **Power of Attorney**

Form Customs Brokers use to act on importer's or exporter's behalf

#### **Red Light**

Physical inspection of goods in Mexican or U.S. Customs compound

#### Registered Importer

A permit that allows a company to import Foreign goods

#### RFC#

Mexican tax ID number

#### Revision

Classification and inspection of product and paper work by a Mexican broker

#### SED/Shippers Export Declaration


Document required on U.S. origin shipments when commercial invoice has one commodity with value over \$2500.00

Document used for goods traveling through U.S. on a temporary basis

#### VAT

Value added tax - see IVA
