Minimal Occurrence Zone/Low Density (General Elk)		
Hunt No.	Number of Permits	Unit
3799	731	12A,12B, 13A, AND 13B

Hunt No. 3799 - Units 12A, 12B, 13A, and 13B have an extremely low-density elk population, about 40-50 elk combined for all four units. These units are specifically managed for wildlife values other than elk, and an established elk population is not desirable. The intent of this hunt is to eliminate this elk population. The cost for this tag has been reduced to \$35.00 to help achieve this objective. The Department cautions you that due to extremely low elk densities, hunt success will be very low, likely less than 5%.

Please note that if you apply for Hunt No. 3799 in addition to any other hunt numbers you must include the higher tag fees. If you are unsuccessful for the other hunt numbers and are successful for Hunt No. 3799 you will be refunded the difference in tag fees.
